### SENATOR THE HONOURABLE RUEBEN RAHMING

Thank you, Madam President. Madam President, I'm just looking at something from The Daily Mail that underscores something that is critical in our country which I have stated on many of times from this place under the next; that we all should be on one accord when it comes to the representation of our country and protecting our country's image.

Now in this matter, I don't necessarily fault the Attorney General because his speciality is not in criminal law.
